# 2021 Summary of Rules for RV Parking at Fort Henry



This is only a summary of basic rules based upon the regulations and by-laws made under the authority of the St. Lawrence Parks Commission (SLPC) Act. For a complete description, please refer to this Act, Regulation 1023 and the SLPC By-Laws. These documents are available for examination at the Park Office or The St. Lawrence Parks Commission Administration Building (13740 County Road 2, Morrisburg, Ontario, KOC 1X0). The penalty for violation of the laws that apply in the Parks of the St. Lawrence parks may be eviction from the park or a fine imposed by the Courts or both.

# FOR YOUR INFORMATION:

- At the time of reservation, all fees are charged to your payment card.
- Reservations of RV parking spaces are nonrefundable.
- RV parking at Fort Henry is dry parking (boondocking).
  There are no utilities or amenities including water, electricity, washrooms, and dump stations.
- 2-for-1 admission to Fort Henry is offered to guests participating in RV parking. Discounted admission is redeemable at the ticket booth for the day of arrival or departure with proof of RV parking purchase.
- departure with proof of RV parking purchase.
  RV parking is only available for towable or drivable trucks, campers, and RVs. Pitching of tents is NOT permitted.

#### **Parking / Additional Vehicles**

Guests must have a paid reservation to park in an RV parking space. One RV/camper per space. Spaces are not assigned and are selected by guests on a first come, first serve basis. Additional vehicles may be parked in the public lot, but not in other RV spaces.

## Check-In / Check-Out

Self-check-in is 2:00 PM or later by scanning the QR code on the signpost in your selected RV parking space and filling in the required forms. Check-out is by 10:00 AM the morning following your last booked night. Guests may to relocate their vehicle to the public parking lot if they wish to stay on the grounds beyond their reservation.

## **Garbage Collection**

Please have regard for the condition of your site and leave it in a clean state. Any garbage should be left in a tied bag next to the signpost of your parking space by the 10:00 AM departure time.

# **Maximum Length of Stay**

The maximum length of stay, in one parking space, is 3 nights.

## **Extending Your Length of Stay**

Additional nights of stay may be purchased through the booking system on the Fort Henry website, provided there is availability.

## **Shortening Your Length of Stay / Refund**

Reservations of RV parking spaces are non-refundable.

# **Number of People Per RV Parking Space**

Maximum of six people or a single family (of parents and children under the age of 18 years).

#### **Visitors**

The land surrounding Fort Henry is public property is open to casual users at any time. Visitors must not park their vehicles in designated RV parking spaces.

## **Redemption of Discounted Fort Henry Admission**

Guests participating in RV parking are eligible for 2-for-1 admission to Fort Henry on the day of arrival or departure by providing proof of RV parking purchase at the ticket booth. Discounted admission is not available for online ticket purchases.

#### **Leaving Vehicles Unattended**

Your vehicle should never be left unlocked and unattended, except in an area designated for that purpose. Fort Henry and the St. Lawrence Parks Commission are not responsible for any lost, damaged, or stolen items of personal property.

#### **Site Resources**

Please help us to protect the land so that everyone may enjoy the site's beauty and history. Remember, it is against the law to remove or destroy anything in the Parks of the St. Lawrence.

#### **Smoking / Vaping**

Smoking and vaping are forbidden in any Parks of the St. Lawrence buildings, any common open patio areas, any nature trails, and 9 meters from entrances of buildings.

## Washroom Access / Dump Stations

There is no public access to washrooms and no dump station.

# **Limited Generator Use**

Limited use of generators will be permitted only during the hours of 8:00 a.m. to 10:00 a.m. and 5:00 p.m. to 7:00 p.m. Generators must be quiet-running and must be enclosed in a structure or self-contained in RV units. Industrial-type generators are prohibited. No electricity source is provided.

## **Loud Noise - Disturbing Other Persons**

Be considerate. Please keep the volume of your music, voices and other noises to a reasonable level. Interfering with anyone else's use or enjoyment of Fort Henry grounds, day or night, is not only inconsiderate - it is also contrary to park regulations. Quiet hours are enforced 24 hours a day.

## **Campfires / Firewood**

Campfires are not permitted. Please not build your own campfire. No exterior firewood is permitted on SLPC properties due to invasive insects and diseases which cause harm to wooded areas.

# **Fireworks and Firearms**

Fireworks and firearms are prohibited, except by regulation.

# **Swimming**

There is no swimming area at Fort Henry.

# **Bicycles**

Bicycles are allowed on roads and bike paths only.

# **Alcoholic Beverages**

Drinking, or the possession of an open alcoholic beverage container, is not permitted on Fort Henry grounds.

### **Sales of Goods and Services**

Only authorized concessionaires are permitted to sell goods and services in the Parks of the St. Lawrence.

# Pets

Pets must be controlled and on a leash of less than two meters.

**NOTE:** You must clean up after your pet. Out of province visitors should confirm breed restrictions at
